

The Property Management team has a balancing act.

Our building is aging and society is changing. Think about things that age or have changed like doors and windows; electrical service; roofs and HVAC; security and technology. The team reviews the building for maintenance needs and improvements and then evaluates those potential projects based on:

Is this a safety issue or is it required by law?

- 1. What impact will this work have as a support to our ministry?
- 2. How much will it cost and is it cost effective?
- 3. Has funding already been designated, available or needed?
- 4. Is this a need or a luxury? If necessary, is it necessary now or later?
- 5. Can work be done by volunteers or is a contractor needed?
- 6. Should the project be done at all or not?
- 7. Who is willing to coordinate necessary work by getting estimates and coordinating with appropriate volunteers or contractors?

More participation in this work is welcome either on the Property Management team, as a project manager or as a volunteer. Let us know if you have any skills or interests that you or someone in the congregation may have that could be helpful. Tell us about any building and property needs that you think need to be addressed.

Auditors' Report for Fiscal Year Ending June 30, 2024

I have reviewed the financial records for the fiscal year ending June 30, 2024, and to the best of my knowledge the records accurately represent the financial position of Prince of Peace Lutheran Church.

Based on this audit, I would like to make the following recommendation to the Finance Committee, Caryn and Kristin. Ensure retention of documents related to significant credit and debit movements in designated and undesignated dedicated accounts. These would include documents on the formation and scope and process of authorization of designated committees and meeting minutes related to authorization of significant spending amounts at or above the council designated and/or those imposed by the congregational bylaws. The key accounts identified although not limited to are 1) Building Funds, 2) Rooted and Reaching, 3) Endowment, 4) Sacred Settlement PoP and 5) Diestler Estate.

While it is not completely under the control of the nominating committee, any effort to add one more person to the audit committee would be much appreciated, as this would help ensure accountability and adequate resources to future audits. In closing, I would like to commend Caryn Josephson and Kristin Bloxham on their handling of the financial functions for Prince of Peace during this period.




